University of Technology, Nowshera (UoT), a public sector university, located in the Ex-Adamjee Paper and Board Mills, Amangarh, Nowshera, invites sealed bids from original well reputed manufacturers/authorized distributors and suppliers, registered with Income Tax and Sales Tax Departments, and who are on Active Taxpayers List of the Federal Board of Revenue, for supply, installation, testing, commissioning and training of UoT personnel of laboratories equipment on F.O.R./ C&F UoT, Nowshera basis. Sealed bids must include 2% of the total quoted price as Earnest Money in the form of CDR in PKR.

Bidding Documents, containing detailed specifications of laboratories equipment, and other terms and conditions of the Contract, are available on payment of Rs.1,000 (non-refundable) from the office of Assistant Director (P&D)/Deputy Registrar, University of Technology, Nowshera, from the date of advertisement till 20-12-2017 up to 10:30 AM.

The bidders should provide proof of registration with FBR and authorized dealership. A pre-bid meeting of tenderer's shall be held on 11-12-2017 at 11:00 AM at UoT, Nowshera in the above mentioned office, to address any queries or clarifications in the tender documents but bidders/firms will submit the queries in writing, if any, prior to the Pre-Bid meeting.

As per the instructions in the Bidding Documents, the Technical and Financial proposals should be submitted in two separate, sealed envelopes, placed and sealed in one big envelope (KPPRA Single Stage, 2 Envelope Method), up to 20-12-2017, and before 10:30 A.M, in the Tender Box placed at UOT, Nowshera. Tenders received after due date and time will not be considered.

Technical Proposals will be opened on the same day, i.e. 20-12-2017 at 11:00 A.M in the Conference Hall of UOT, Nowshera, in the presence of the bidders or their authorized representatives.

Financial Proposals of only those firms, who are declared technically qualified for participation, will be opened on a subsequent date, which will be communicated by UoT, Nowshera to all technically qualified bidders or their authorized representatives. Sealed Financial Proposals will be returned to bidders who are declared unqualified on the basis of Technical Proposals and CDR's of them will be returned upon written request.
