The meeting started with name of Allah. Thereafter, Dr. Haider Ali, Chair of Procurement Committee welcomed the participants. The chair apprised that the tender was floated and in response 10 bidders participated. After the opening of technical proposals, a Technical Committee was constituted for evaluation of technical bids. In the preliminary evaluation, the Technical Committee found all 10 bidders as responsive as detailed at Annexure "I". Subsequently, the Evaluation Committee thoroughly evaluated the bids from technical aspects and marked each item as compliant/non-compliant as detailed at Annexure "II".

Subsequently, the Procurement Committee examined the evaluation reports of Technical Committee in its meeting held on 30.01.2023 and endorsed the same. Thereafter, sealed financial bids of responsive and technically qualified bidders were opened by the Procurement Committee in the presence of representatives of bidders. The rates against each compliant item(s) were announced loudely. After opening of financial bids, the Committee proposed that before final recommendations, a market survey may be conducted so as to ensure competitiveness of the quoted rates. Accordingly, the Committee conducted market survey of all the items.

Based on the market survey and financial comparative statement, the Committee unanimously recommended that contract may be awarded to the following bidders for supply of items as noted against each on FOR basis:
