## TECHNICAL EVALUATION REPORT FOR PROCUREMENT OF CCTV SURVEILLANCE SYSTEM

- 1. Introduction: The requirement is for the procurement of CCTV surveillance system under the ADP Scheme "Establishment of Khyber Pakhtunkhwa University of Technology at Nowshera". Open competitive bidding was used and approved by the competent authority.

The advertisement was also uploaded on the UoT Nowshera website as well as Khyber Pakhtunkhwa Public Procurement Regulatory Authority's website. Bids were closed on 07.02.2023 at 11:00 a.m. at the tender box of UoT Nowshera.
- **3. Details of Bid Opening: -** Bids were opened in public in the Conference Room of UoT Nowshera by the Procurement Committee on **07.02.2023** at **11:30 a.m**. The meeting was also attended by the representatives of the bidders.
